TAKE NOTICE that the Michigan Department of Environment, Great Lakes, and Energy (EGLE) Water Resources Division (WRD) will hold an online public hearing on December 8, 2022, at 6:00 p.m.

The purpose of this hearing is to secure the views of interested persons concerning the following application for permit:

Application for permit HPK-P6DJ-H3F3X under Part 31, Floodplains, and Part 301, Inland Lakes and Streams of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA), by Mark D Steffke, Macatawa Bay Yacht Club; 2157 South Shore Drive, Holland, Michigan, 49423. The applicant, Macatawa Bay Yacht Club, proposes to construct one, 204-foot by 8-foot approach dock; one, 215-foot by 8-foot approach dock; one, 96-foot by 8-foot head dock; one, 277-foot by 8-foot head dock; one, 88-foot by 5-foot T dock; one, 35-foot by 5-foot T dock extension; six, 50-foot by 3-foot finger docks; 18, 40-foot by 3-foot finger docks; remove six, 12-inch wood spring pilings; and install 57, 12-inch wood spring pilings to facilitate the addition of 37, 40-foot boat slips and 13, 50-foot boat slips for a total of 50 additional boat slips to their existing 77 boat slip marina. The project is located in T05N, R16W, Section 33, Park Township, Ottawa County, Michigan.

The hearing will not be a legal proceeding, witnesses will not be sworn, and there will be no cross examination. Public hearings are primarily informational and are held to encourage the expression of views and presentation of facts.
